**Sub: Regarding conduct of Examinations of Exit classes in Technical Universities and Engineering/Polytechnic Colleges of Punjab state.**

With reference to the above subject it is informed that the UGC vide letter dated 06.07.2020 had issued the guidelines to conduct the final exam by 30.09.2020. Further the Hon'ble Supreme Court while disposing of the bunch of the writ petitions with CWP No. 724 of 2020 vide order dated 28.08.2020 also upheld the decision of UGC to conduct examination of Exit Classes before 30<sup>th</sup> September 2020. Pursuant to these orders it is directed that;

1. The Universities/Board will complete the examination process of all exit classes at their campuses as well as in the colleges affiliated to them tentatively by 15<sup>th</sup> October 2020. UGC has been requested to allow accordingly.
2. The Universities/Board will decide on their own about mode of conduct of examination.
3. While conducting these exams all necessary precautions like sanitization, temperature monitoring of all students & staff and social distancing will be strictly adhered to, as per instructions/SoP's issued by Health Department of State Government/Central Government.
4. The Universities/Board will ensure that proper arrangements are in place in case of holding physical examination.
5. The Universities/Board will ensure that the students are informed through all possible means
